

Barber Bundle · Service Agreement

Issued on the shoot day cycle beginning 2026-08-03 · Governed by Ontario law

12-MONTH TERM · CANADIAN DOLLARS

\$1,000 CAD

The AMA signature. Every Platinum benefit plus bi-weekly grooming.

This Agreement (the "Agreement") is entered into between Aura Modeling Agency ("AMA") and the undersigned talent ("the Talent") in the Province of Ontario, Canada. It governs the services provided under the package purchased below for a period of twelve (12) months from the activation date, unless terminated in accordance with the Termination clause.

WHAT AMA PROVIDES

For the duration of the 12-month term, AMA will deliver the following services in exchange for the one-time package fee shown above. Every included item below is a firm commitment; every excluded item is a legitimate expectation the Talent should NOT hold under this tier.

- **Everything in Platinum**
All Premium and Platinum services are inherited (except where superseded below).
- **Coral username glow**
The talent's name is displayed with the signature Barber Bundle coral glow — instantly identifiable across the platform.
- **Bi-weekly professional cuts**
One professional in-house barber session on EVERY 15th and 30th of every month for the full 12-month term. In months without a 30th (Feb non-leap), the 15th session still applies.
- **Included Hotdrop barber slots**
All Hotdrop day barber appointments are fully covered — no \$150 fee, no cancellation penalty.
- **Complete grooming service**
Every cut includes the AMA six-step process (Consult, Prep, Cut, Line-Up, Style, Finish) with hot-towel and product application.
- **One free makeup / grooming touch-up per month**
Same as Platinum — one free makeup or grooming touch-up session per calendar month.
- **Barber Bundle roster badge**
A distinct badge on the talent's public roster card marking the highest-tier signature membership.

NOT INCLUDED AT THIS TIER

- Grooming services outside AMA shoot days or approved appointments (see Off-Day Booking section on Careers page)
- Product retail (barber tools and take-home product are not included)

PAYMENT & REFUND

The one-time package fee of \$1,000 CAD covers the entire 12-month term. Payment is processed through Stripe (Managed Payments, Canada). Fees are non-refundable once the term is activated; a term may be paused for a genuine health or force-majeure reason at AMA's discretion, resuming upon return.

TALENT OBLIGATIONS

The Talent will keep their profile information current, respond to booking requests within 48 hours, arrive on time and shoot-ready on confirmed shoot days, follow the AMA code of conduct, and never solicit clients or crew for services outside this Agreement without written approval from a founder.

TERM, TERMINATION & GOVERNING LAW

This Agreement is effective from the activation date and runs for twelve (12) months. AMA may terminate immediately for material breach (unsafe conduct, no-show on a confirmed shoot day, breach of confidentiality, or misrepresentation). The Talent may terminate with 14 days' written notice; unused portions of the fee are not refunded. This Agreement is governed by the laws of the Province of Ontario, Canada.
